



## Pool and Spa Cover Rebate Program Rebate Guidelines and Application

### Program Information

This program will assist customers with costs associated with the purchase of a swimming pool and/or spa cover to reduce the amount of water lost to evaporation and the cost of pool maintenance.

### Rebate Amount

With a completed application form and proof of purchase, District customers will receive the receipted value of their pool or spa cover, up to \$50 per cover.

### Application Instructions

- Within 30 days of your pool/spa cover purchase:** Submit the rebate application and a copy of your itemized receipt or paid invoice from a vendor to the District. Submission options:

- Once your application has been approved, DSRSD will credit your account for the rebate value.

### Program Requirements

- To be eligible for the pool cover rebate, you must be a current customer and your account must be in good standing with the District.
- The rebate is limited to one pool cover and/or one spa cover per service account.
- Rebates are for covers specifically made for pools and spas.
- Rebates do not apply to second-hand covers or mesh covers.
- Applicant agrees to allow District staff access to the pool/spa for field verification.

### Program Benefits

A properly fitted pool cover:

- Reduces evaporation by 90-95%, or by 6,000 to 8,000 gallons per year
- Retains heat by up to 6-8 degrees
- Prevents 80-90% of debris in the pool
- Reduces chemical application and workload on pool cleaning equipment
