DUBLIN SAN RAMON SERVICES DISTRICT MINUTES OF A REGULAR MEETING OF THE BOARD OF DIRECTORS

April 20, 2021

General Manager McIntyre advised the Board of a typo in the Item 7.A draft minutes under Item 8.B – he noted the Hopyard Well should be identified as #3 instead of #7.

Director Vonheeder-Leopold MOVED for approval of the items on the Consent Calendar, with the correction to be made to the April 6, 2021 Regular Meeting Minutes as noted. Director Rubio SECONDED the MOTION, which CARRIED with FIVE AYES per roll call vote.

8.A. Approve Continuation of District's State of Emergency in Response to COVID-19
Pandemic by General Manager and Find that the Need for the District's State of
Emergency Still Exists

Vice President Halket MOVED to Approve Continuation of District's State of Emergency in Response to COVID-19 Pandemic by General Manager and Find that the Need for the District's State of Emergency Still Exists. Director Vonheeder-Leopold SECONDED the MOTION, which CARRIED with FIVE AYES per roll call vote.

8.B. Approve Intention to Levy Annual Assessments in the Dougherty Valley Standby Charge District 2001-1 for Fiscal Year Ending 2022

Financial Analyst Mayette Bailey reviewed the item for the Board. The Board and staff further discussed the history and purpose of the assessment. Staff confirmed that the assessment is a "pass-through" that DSRSD facilitates on Zone 7 Water Agency's behalf for the cost of water services to parcel owners in Contra Costa County. Staff also explained that the California Department of Water Resources State Water Project determines the cost of the service each year and does a reconciliation the following year to "true-up" any cost adjustments to the parcel owners.

Director Vonheeder-Leopold MOVED to Approve Resolution No. 20-21, Intention to Levy Annual Assessments in the Dougherty Valley Standby Charge District 2001-1 for Fiscal Year Ending 2022. Director Goel SECONDED the MOTION, which CARRIED with FIVE AYES per roll call.

8.C. Approve Nomination of Director Georgean Vonheeder-Leopold as the Alternate Special District Member to the Alameda County Local Agency Formation Commission (Alameda LAFCo) and Appoint Alternate Voting Delegate

Management Analyst I Vivian Chiu reviewed the item for the Board. The Board commended Director Vonheeder-Leopold for her years of continued service on the Alameda LAFCo Board of Directors.

Vice President Halket MOVED to Approve <u>Resolution No. 21-21</u>, Nominating Dublin San Ramon Services District Director Georgean Vonheeder-Leopold for the Alternate Special District Member Seat on the Alameda County Local Agency Formation Commission (LAFCo). Director Rubio SECONDED the MOTION, which CARRIED with FIVE AYES per roll call vote.

Director Rubio MOVED to Appoint Vice President Halket as the Alternate Voting Delegate to the Independent Special District Selection Committee Election on May 12, 2021. Director Goel SECONDED the MOTION, which CARRIED with FIVE AYES per roll call vote.

8.D. Discuss the Special District Leadership Foundation's District of Distinction Accreditation Program and Provide Direction Regarding the District's Interest in Participating

Executive Services Supervisor/District Secretary Genzale reviewed the item for the Board. The Board and staff discussed facets of the program including the training requirements, associated program costs (application fee, trainings, staff time), and benefits of pursuing the accreditation.

Director Vonheeder-Leopold MOVED to Direct Staff to Begin the Application Process for the Special District Leadership Foundation's District of Distinction Accreditation Program. Director Rubio SECONDED the MOTION, which CARRIED with FOUR AYES and ONE NO (Halket) per roll call vote.

8.E. Adopt Revised Water Supply, Storage, Conveyance, Quality and Conservation Policy, Renamed to Water Resiliency Policy, and Rescind Resolution No. 89-15

Assistant General Manager Lee reviewed the item for the Board. The Board discussed various aspects of the current policy and the proposed policy revisions. The Board also conveyed its appreciation that the revised policy has a two-year review timeline so the Board can make timely adjustments in alignment with ongoing Tri-Valley supplemental supply efforts and in consideration of the District's next proposed budget.

Director Goel MOVED to adopt <u>Resolution No. 22-21</u>, Revising the Water Supply, Storage, Conveyance, Quality and Conservation Policy, Renaming the Policy to the Water Resiliency Policy, and *Rescinding Resolution No. 89-15*. Director Vonheeder-Leopold SECONDED the MOTION, which CARRIED with FIVE AYES per roll call vote.
