Revenue Assumptions

- **➤** Service Charges Rates
 - Local Wastewater final year of aggressive 5-year program
 - Regional Wastewater & Water @ CPI
 - Water demand Growth tempered by drought conservation
- **≻**Capacity Reserve Fees
 - Increased revenue after COVID
 - Based on city projected DUEs

District Growth Since 2009

- Our Service Area has expanded
 - —Potable water lines 14.2% +
 - -Sewer lines 11.6% +
 - —Recycled Water lines 33.3% +
 - —Recycled Water flows 57%+
 - -Customers 45% +
- Our Staffing has kept status quo
 - 134 FTE vs 131 proposed






